## <u>Overview</u>

This document details the steps required to access the data extract application. This process should only be done by clinic managers or those given the task to do so.

## <u>Access</u>

To access the Data Extract page please navigate to <u>www.onesightclinics.org</u>. At the top of the page click on the option for "Admin". It will be under the "More" section as seen below:



On the admin page you will select the option for "Data Extract" as seen below.

Next, you will be on the "Patient Data Extract" page. Here you will be able to search for clinics with the following criteria

Clinic Name - Drop down with a list of all clinics.

First Name – The first name of the patient.

Last Name – The last name of the patient

**School Name** – Drop down of all school, groups, and communities that are a part of the clinic you chose.

After you have filled in the desired information you can click the blue button at the bottom labelled "Search."
